Using the benefits enrollment system is easy and convenient. Each employee creates an individual username and password to log into the portal.

- The **Welcome Screen** provides instruction and information for employees before they click “Start” to begin enrolling in benefits.
- **About You** features employee specific information that can be edited and updated if necessary.
- **About Your Dependents** allows you to edit or delete existing dependents and add a new dependent.
- **Your Benefits Snapshot** summarizes current elections, employee premiums, and dependent information, if applicable.

As employees move through the benefit screens to elect **Medical, Dental, Vision, Flexible Spending Accounts, Disability, and Life, AD&D Insurance and other voluntary programs**, they are able to select the coverage they want as well as see the cost for all coverages. In addition, for the

voluntary insurances, they can select beneficiaries and even complete Evidence of Insurability forms.

Once enrollment is completed, the **Enrollment Summary** page lists the employee’s elections, total monthly contribution, and dependent information. A confirmation page can be printed for the employee’s records, and clicking “Submit Elections” complete the enrollment.
